FCOC Business Meeting – August 16, 2006 Lowe's Motor Speedway, Charlotte/Concord, N.C.

A motion was made by Ed Casada and seconded by Barb Knutson to re-elect Roy Hopper as Alternate National Director. There was no discussion and the motion carried.
