#### Dear Friends;

Wow!!!! What a couple of months and have they gone by in a hurry. I can only say, I am here to tell you an amazing two months worth of learning and changing and realizing how I appreciate you and the prayers you offered up on my behalf. Thank you, all of you for helping me appreciate the beauty and benefits of friends and people like you. I am living proof that Prayer Power works. All I can say is that you are the greatest group of caring people in the entire world.

Sometimes we get discouraged with the happenings around us, our thought process is one of question and then a new look at life and how blessed we are because we made it through a rough experience. The calls and cards I have received, all offering prayers and for anything they could do. What a fantastic feeling of warmth and love hearing from you. Thank you so much for keeping Dorothy and me going in the right direction.

With this experience, I have a personal goal. You know how I say that when we go to a presentation or training program, if we learn just one thing that will be a benefit to us, then our time and effort has been worth it. Well, if I bring a little knowledge that could save just one person from going through what I went through, then my little example will have been a success.

Ok here it is in a nutshell, (I hope) A little background first and it includes the after weeks of a heart attack. I came home from Tyler feeling just wonderful and really blessed. We were then to visit my cardiologist for further instructions. The visit was very positive and he even thought, I was such an active person, that I really did not need the rehab as most patience have. Dorothy and I thought it would be good to now know just how much I could do before I reached my limit. What could I do and what could I not do, that was the question. I learned, what I believe to be the greatest process of our body. It had to do with stress. Yes, Stress. I learned that any work we do around the house or the motor home or yard or whatever, is just another form of stress. Stress is what causes heart attacks, in one form or another. I was the active one. Always doing something, motor home, car, concerning myself about everything. Busy work, just busy work. I am under the impression that activity is good for the heart and blood pressure. WRONG!!! Exercise is what is good for the system and no other substitute.

My example is this. I would enter the hospital rehab unit and they take my blood pressure. 165/86 and I was wondering why it was so high. I walked up stairs, cleaned up outside, did some minor polishing on the motor home. Why was my blood pressure up???? I would them warm up by stretching and bending and just get loose in a small way. Then I would spend 15 minutes on a treadmill walking 2.6 MPH. Really not fast enough to work up a sweat. Just fast enough to get my pulse up to a reasonable level. And then to a bicycle that had pedals and arm rods for upper body exercise. 15 Minutes again and not fast enough to break a sweat. 1.0 MPH and then the blood pressure was taken and guess what 135/70.

The explanation is as follows. Exercise opens up the veins and arteries and allows more oxygen and fresh blood into your heart. Somewhat like the stint has done. I feel better now than I did before the heart problem and after 15 rehab sessions, my blood pressure has made a significant drop and all with just a little exercise of walking about 2 miles per day. It takes about 45 minutes to 1 hour and that can reduce the chance of added stress or more heart damage

I also received an e-mail from a FCOC member that read the last newsletter and emailed the warning signs she had with a heart attack. There are many ways that our body can warn us. She experienced pain in her jaw and after a few days, she went to the dentist for an analysis of her jaw. The dentist could not find a problem and sent her home with 2 aspirin and that it would wear off. After 2 more weeks of continued pain, she went to the doctor, and he identified a 100% blocked artery and immediately did a stint installation and saved her life.

My point here is that, we should pay attention to our body and the different ways it tells us that something is not right. Tell somebody and keep pursuing the tests until all is clear and right.

Working out or even walking is a sure way to prevent a severe attack that could keep you from enjoying life on wheels.

Co-pilots or spouses, keep your eye on what is going on and help identify a possible problem with the pilots health or your own.

I hope that this information is enough to help you in preventing a health problem. Again, I thank you for your love and prayers and wish you all the best of travels.

- 1 Fresh beef brisket (2 1/2 pounds)
- 1 tablespoon Liquid Smoke
- 1 teaspoon salt
- 1/2 teaspoon pepper
- 1/2 cup chopped onion
- 1/2 cup ketchup
- 2 teaspoon Dijon mustard
- 1/2 teaspoon celery seed



Cut the brisket in half; rub with Liquid Smoke, salt and pepper. Place in a 3 Qt. slow cooker. Top with onion. Combine the ketchup, mustard and celery seed spread over meat. Cover and cook on low for 8-9 hours. Remove brisket and keep warm. Transfer cooking juices to a blender; cover and process until smooth.

Serve with brisket. Yeild 4-6 servings. Note: this is fresh brisket not corned beef.

# Congress Replaces National Recreation Fee Demonstration Program

The National Recreation Fee Demonstration Program, created in 1996 as a three-year experiment, will soon be replaced by a new recreation fee program that will cover five federal agencies and provide a 10-year fee authorization. The agencies included in the program are the National Park Service, the Forest Service, the Bureau of Land Management, the Fish and Wildlife Service, and the Bureau of Reclamation. The new Federal Lands Recreation Enhancement Act is based upon legislation approved by the U.S. House of Representatives Committee on Resources.

The new federal recreation fee program is supported by most recreation and tourism interests, largely because at least 80 percent of the fees collected will be retained at the local sites and should result in improved visitor experiences. Other key provisions of the legislation include:

- Well-defined guidelines on where recreation fees may be imposed, specifically prohibiting fees for locations that proved most controversial during the fee demonstration program.
- Clear direction to the five federal agencies to coordinate fee programs and avoid multiple or layered recreation fees.
- Continued special treatment for certain Americans, exempting or charging nominal fees for children, seniors, people with disabilities, and schools.
- The creation of a two-tier daily/short-duration fee program for Bureau of Land Management (BLM), Forest Service, and Bureau of Reclamation lands; a standard amenity recreation fee; and an expanded amenity recreation fee when the use of special facilities (including campsites) or the receipt of special services is involved.
- Explicit requirements for public involvement in the development or changing of a recreation fee and for reporting on the use of collected fees.
- A new interagency annual pass called the "America the Beautiful the National Parks and Federal Recreation Lands Pass." All other national passes are prohibited, including existing single-agency passes. The new pass may be marketed through government and non-government entities. The pass will be valid for 12 months after purchase (not for a specific calendar year), and when purchased by a citizen or person living in the United States over the age of 62, will cost \$10 and be valid for the pass holder's lifetime. Details about the pass will be determined by the secretaries of Agriculture and the Interior but are expected to resemble those that now apply to Golden Eagle and National Park passes.
- The authority for site-specific annual passes.
- The authority for special recreation permit fees for group activities, recreation events, and motorized recreation vehicle use.
- The authority for regional, multientity passes that could cover areas managed by a variety of federal, other governmental, and nongovernmental entities for periods up to one year including federal agencies not included under this legislation, such as the U.S. Army Corps of Engineers.
- The authority for discounted and free admission days.

According to Derrick Crandall, president of the American Recreation Coalition, the result of this legislation should be \$200 million or more in new resources every year above and beyond appropriations. "Fees will remain only one part of caring for our legacy of public access to public lands by anyone, regardless of their financial situation," he said.
