

We will be electing new officers and that note is also in this newsletter. And we will be updating the by-laws for the registration issue. Of course there will be a Party after the Business meeting. (#2) Yakima Fair Grounds is the location of the FCOC rally immediately after the FMCA Convention, "Yakima Mountain". Be sure to register for this one it will be a lot of many good things. #### THE LEADER AT EVERY TURN"

#### Hello FCOC Members,

We have been busy at FCCC working with our OEM partners on new model introductions with the new EPA 07 engines. Along with the new engines there have been some new chassis configurations like the new XCL recently introduced by Winnebago that offers a new concept for pass through storage on their high end lines. Standard with chassis with the 07 engines will be the lowered engine position allowing for a flat or near flat bedroom floor. On chassis with the rear radiator we have made the fan clutch standard which provides about a 1.5 mpg improvement in fuel economy.

Engine ratings have changed with the EPA 07 engines. Cummins has increased the displacement on the ISB to 6.7 liters and has ratings available from 300hp/620 lb ft torque to 350hp and 750 lb ft torque. There is also a rating of 340hp 660 lb ft torque. Cummins also increased the horsepower rating for the ISC to 360 hp and the ISL to 425hp. Allison has also upgraded the 1000 and 2000 series transmission to a 6 speed for this year.

The 340hp ISB has become a very popular option for the FRED chassis. In addition to Tiffin, Gulfstream and Safari, we now have Newmar, Damon, Triple E building on Fred and are working with a couple of other OEMs for a Louisville debut.

The FCCC team will be out in Redmond for the FMCA rally and at the FCOC rally in Yakima in August. My intention is to stay in a coach with our FCOC owners at both events. I look forward to getting a chance to meet many of you and welcome your comments. I encourage you to seek me out at these events and let me know what is going on from our customers' perspective. I am especially interested in where you see our opportunities for improvement.

Joining us in Redmond and Yakima will be Jonathan Randall, our new Director of Sales and Marketing replacing Dean Schaper, who is retiring at the end of August after many years of outstanding service to FCCC and FCOC.

I hope that all of your summer travel plans are working out well.

#### How You Get Your Newsletter and "Keeping in Touch"!

#### READING THE INFORMATION ON YOUR NEWSLETTER LABEL

I receive a few contacts from members every month and a many contacts toward the end of the year; all asking, "When are my membership dues up for payment?" or, "Am I paid for this year?" The label of your newsletter has the answer to what year your dues are paid up to. I enclosed my address label as a sample.

The first thing to check is your F-number so as to be sure that it is correct. What follows that is the date and year your dues will expire. I obviously will have to pay my dues before 12/31/09. The rest of the label is the name, address and zip. Please check for proper spelling. If you find anything not quite right, correct it at the "keeping in touch" access point under membership at our website, **freightlinerchassisownersclub.org**, or please contact me by E-mail, letter, or call me and I will update the database for you. We really stride to not only keep the database current, we do want it to be accurate.

I was chatting with someone recently who told me that they move around two, three or more times a year, so he was reluctant to keep "bothering" us with changes. My response was that it wasn't a bother to correct an address, but it was a problem to get a newsletter returned with or without a new forwarding address for four reasons.

- 1. You didn't get your newsletter.
- 2. The club has to pay .75 to \$2.06 cents when the newsletter is returned to me.
- 3. I have to enter the changes or enter that the current address is a bad address.
- 4. Until the address is corrected, no further newsletters will be mailed to you at that bad address.

Remember you can go into the database at our website at: **freightlinerchassisown-ersclub.org**, then go to **membership** and click on the "**keeping in touch**" button. The first time you access your membership profile, the *password* is your five character <u>zip code</u> or your seven character (includes space) postal code. You should change your password once you have logged into the system. Our Canadian members have been having a problem signing in. The database folks are working on this problem as I write. They hope to have the sign in process for our Canadian members working very shortly, so the sign in as described above will be effective very soon.

Once logged in, **please update your information** in each of the categories across the top of the screen. Most important, is to remember to click 'Save & Continue' after you've made changes under any of the categories.

The bottom line is we volunteered to do this job (that means to do it right) and we cannot do it unless we get an assist from you, so please if you have a change of address, correct it in the database. If for any reason you want us to correct the database, notify us and we will put that change in wearing a smile and we will thank you for taking the time to help us.

#### "E-mail Opt-In" for E-Mail Communication

As our club grows in size we need to learn to work smarter – not harder. There are a number of reasons to contact members via e-mail. However, your Board of Directors is very aware that some club members do not want to receive email from the FCOC.

These communications may include, but are not limited to, dues renewal reminders, requests for help at a rally you have registered to attend, or notification of upcoming club events. In no case will your e-mail address ever be sold or provided to any other organization."

Please take the time to review, and correct if necessary, your personal information. At the same time please Opt-In if you would like to receive e-mail from the club. To review your information, go to the Membership Page on the club's web site at

## Heads Up ...this one will effect us All! **Proposal to Amend the FCOC Bylaws**

The FCOC Board of Directors is recommending that the membership period be changed from the current calendar based membership year to an anniversary based membership year. Currently, every member (except those in years 2, 3 or 4 of a five year membership) must renew their membership in January of each year. As the club continues to grow in size, the workload required to process renewals is becoming unmanageable.

An anniversary based membership year will distribute the workload throughout the year. When a new member joins FCOC, their membership will extend until the last day of the month in which they joined the following year. For example, if a member joins the club on June 18<sup>th</sup>, 2007 for one year, they will need to renew their membership on June 30<sup>th</sup>, 2008. In time this change will distribute member's renewals throughout the year and even out the workload. Note that FMCA, credit card companies and DMV's in most states already use anniversary based renewals.

There are other minor proposed changes to the bylaws to correct grammar and spelling errors and to provide additional clarification. The marked-up bylaws are available for review on the club's website (http://www.freightlinerchassisownersclub.org) on the Bylaws Page.

#### NOMINATING COMMITTEE REPORT

The members of the nominating committee have communicated by Email, and by phone, and are proposing a slate of officers to be elected at the *August business meeting in Redmond,* 

*Oregon.* In accordance with the by-laws, we have three officers whose terms are expiring at the end of 2006. Ken Hawk (President), Priscilla Buck (Secretary), and Chuck Belba (V.P. of Membership).

Bill Buck, currently our Exec. V.P. has agreed to move into the office of President. That will leave an opening for someone to fill the unexpired term for Exec. V.P.

The Nominating Committee submits the following slate of officers for the election coming up at the August 2007 business meeting.

Once this vote has been taken and provided Bill is elected as the new President – the committee will then nominate for: **Executive-Vice President:** Ron Sliger

Then the vote will take place for

Vice-President Membership: Chuck Belba Secretary: Priscilla Buck

All nominees have been contacted regarding their responsibilities and have indicated a willingness to serve the club.

As a reminder, if anyone wishes to nominate a candidate for any of the above offices, they may do so at the August Business meeting. A motion from the floor, followed by a second and acceptance by the person nominated, will place that person on the ballot. Once the nominations are closed, the election will follow.

Each office will be voted on separately. If anyone is nominated for an open office and accepts the nomination, that person will be given a few minutes to address the membership regarding their qualifications and desire to serve the club.

Since we meet only twice each year and not all members of the committee are present at all meetings, it is difficult for us to communicate with all the members to the extent that we would like. We would request that anyone interested in serving the club in any of the leadership positions, please let members of the Nominating Committee know of your interest.

We continue to recommend to the Executive Board that they consider expanding the number of people on the Board by adding additional Vice-President positions. This action would not require a change in the by-laws and additional administrative ideas and involvement would be most beneficial to our ever-growing club.

In this newsletter is a current list of Freightliner Oasis Dealers. I strongly suggest that you consider using one of these dealers for your repair. Please don't just go blindly in and expect anything but what you ask for. Get an estimate. If they won't give you one, go else ware.

One member went to a Freightliner dealer and asked for an estimate on finding an air leak. They told him they don't give estimates on trouble shooting problems. You know what I would have done??? I would have taken it to Billy Bob's auto repair, Post Office, and Tire repair, before I would enter into this arrangement. He left it there and waited for the repair and noticed the sign on the wall, \$80.00 per hour with a one hour minimum. The problem was identified and it was an air dryer loose and leaking. It took all of 45 minutes. He went to pay the bill, thinking he got off pretty good and was presented a bill for \$400.00 He was then told he had to pay it. There was no discussion on the issue. (Well isn't that special?)

This customer called Gaffney and they told him that it was in order and they could not do anything because they have no control over the dealer. Well folks we do have control. I'm sorry it is our money they are toying with. I am going to make a suggestion. It works most of the time especially when you believe you are being taken advantage of. I use a credit card for the reason of disputing the charge. Most credit cards offer this same service. In this case, this is what I would have done besides taking it else ware. Even the campground might have suggested a local repair facility. Anything but \$400.00.

The game of life is to see how many marbles you can keep on your side of the line. If we can't get help when we need it, then we need to protect ourselves. My suggestion is to be careful no matter where you go for repair. Hope this never happens to you.




