#### ~ President's Message ~

To all of our FCOC friends,



On 13 January 2009, an e-blast was distributed to our membership providing an update on the status of Bill Buck. Because not all of our members have access to e-mail and the situation has changed, a summary of the information contained in the e-blast and an update follows:

Some may have heard, but most of our members were not aware that Bill started experiencing some vision problems following the July FCOC rally at Sunset Lakes, Joslin, Illinois. In late September he had an operation at the Cincinnati Eye Institute to remove a cataract, but that did not correct the problem. Further testing revealed he had a tumor surrounding his optic nerve. On 2 December, Bill started treatment for the tumor at the Midwest Photon Beam Institute, Bloomington, Indiana. He was admitted to the University of Indiana Hospital Emergency Room on 19 December for swelling of feet and legs. An extensive battery of tests revealed that cancer had spread into other areas of his body, and was so invasive that treatment for the tumor on his optic nerve was terminated. Bill and Priscilla were advised they should return home to New Hampshire as soon as possible and arrange for Hospice care. Bill passed away in his sleep on 19 January 2009. He was 62 years of age. Services were held on Saturday, 24 January 2009 at the Pilgrim United Church of Christ, Brentwood, NH. Priscilla is working her way through this tragedy and we need to keep her in our prayers.

During his brief illness, I worked very closely with Bill and always envisioned him coming back and resuming his job as our President. He was a close and personal friend, and it just does not seem right that he is no longer with us. A friend recently told me that bad things happen to good people, and this is a prime example of that happening.

As I write this letter, the economy continues to struggle and the motorhome industry continues to have its challenges. With the recent passage of the stimulus bill, we can only hope the financial situation in our country gets back on track, and in turn, so does the RV lifestyle and our business.

In the meantime, FCCC continues to lead the industry in its "green" efforts. We have adapted our traditional manufacturing processes to the modern challenges of today, proving we are a nimble, dynamic company that reacts quickly to changing market needs and implements innovative technologies into our products, ensuring we remain competitive and at the top of our game. We are a stable, viable and sustainable company, even engineering new, and increasingly "green", products during this economic downturn. We recently enjoyed a highly successful launch of ecoFRED, our hybrid-electric motorhome chassis, and we also continue to offer hybrid-electric and compressed natural gas chassis for the commercial bus and walk-in van markets.

In addition to our environmentally conscious products, the FCCC manufacturing facility is "going green" as well. Gaffney is the pilot plant for the Zero Waste to Landfill Project initiated by Daimler Trucks North America, FCCC's parent company. The purpose of the program is to become 100 percent landfill waste-free by 2010. As of Dec. 31, 2008, we have achieved 90 percent waste-free status, a gain of 62.3 percent for the year over 2007. As a result of this project, FCCC was accepted into South Carolina Environmental Excellence Program, EPA's WasteWise Program and most recently, the EPA Performance Track Program. FCCC was awarded by the Gaffney Vocational Rehabilitation Center, a service of the South Carolina Vocational Rehabilitation Program, for its environmental efforts. We are very proud of these awards and accomplishments and will continue to lead the way toward cleaner manufacturing.

On another internal FCCC note, there have been some changes in our marketing department as we recently said goodbye to a long-time employee who many of you know well. Larry Dorer retired at the end of January and handed over the rally reigns to John Sereno. Please say "hi" to John at the next rally as he is now the main point of contact regarding our trailer and display. John has been with FCCC for almost 20 years and is very capable of filling Larry's shoes. We wish Larry the best and who knows, perhaps we'll all see him again at a future rally if he decides to go RVing as part of his retirement.

I'd also like to extend my condolences to the family and friends of Bill Buck. With his passing, FCCC also lost a great friend and company champion. He will be missed by all of us here.

## FMCA's CORNER

As I write this we are one month from leaving for the 81st National Convention in Perry, GA where I am looking forward to seeing a lot of you.

FMCA has been looking at many ways to reduce our budget over the past months since the Governing Board meeting at St. Paul. At the November meeting of the FMCA Executive Board, a motion was passed to direct the Executive Director to reduce the 2009 budget by at least \$800,000.00. Ms. Connie Pool, FMCA National President, and Mr. Doug Key, FMCA Treasurer, informed us at the FMCA Southeast Area Rally that I attended last week that a large part of that reduction has been accomplished with cuts in the staff at Cincinnati, OH and the outside advertising staff. So now all our magazine advertising will be handled in-house.

A Candidates' Forum will be held at the Perry, GA Convention in Heritage Hall on Sunday, March 15, 2009 from 10:30 am to 12:30 pm. This is an excellent opportunity to get to know the candidates running for National Offices.

The dates for the FMCA International Conventions to be held in 2010 have been published. They are as follows:

FMCA's 83rd International Convention is in Albuquerque, NM from March 22-25, 2010 and the FMCA's 84th International Convention is in Redmond, OR from August 11-14, 2010.

The Executive Board has approved a change to the FMCA Round Bottom Road Campground. Members now have the opportunity to stay at the campground for seven nights. Previously, members were limited to a stay of two nights per month at no charge. However, there wasn't an opportunity for members to extend their stay. Now, members may extend their two free-night stay to a maximum of five additional nights per month for a fee of \$20.00 per night. The RV sites have full hookups and are available to FMCA members on a space-available basis. No reservations will be taken, but members should call ahead to inform the staff they will be staying overnight. Accommodations are on a first-come, first-serve basis.

On January 28, 2009 FMCA completely revamped its web site. The site has many features that it did not have before, such as simple navigation, Product Pavilion, a new search feature to help you find whatever you need, videos on new motorhomes and RV products, and much, much more. We are especially excited about the Community Area where you can share your travel experiences along with photos, participate in more than 45 forums, and even create your own blog. With your participation, the community can be a valuable forum for informal discussion and knowledge sharing among motorhome owners.

How to Survive a Heart Attach when Alone



You are really stressed and upset....

Suddenly you start experiencing **SEVERE PAIN** in your chest that starts to radiate out into your arm and up into your jaw.

You are only five miles from the hospital nearest your home.

Unfortunately you don't know if you'll be able to make it that far.

#### What To Do???

You have been trained in CPR, but the guy that conducted the course did not tell you how to perform it on yourself!!!

Since many people are alone when they suffer a heart attack, without help, the person whose heart is beating improperly and who begins to feel faint, has only about 10 seconds left before losing conscious

#### What to Do???

#### <u>Answer</u>

Do not panic, but start coughing repeatedly and very vigorously.

A deep breath should be taken before each cough, the cough must be deep and prolonged, as when producing sputum from deep inside the chest.

A breath and a cough must be repeated about every two seconds without let-up until help arrives, or until the heart is felt to be beating normally again.

Deep breaths get **oxygen** into the lungs and coughing movements squeeze the heart and keep the blood **circulating**. The squeezing pressure on the heart also helps it regain normal rhythm. In this way, heart attack victims can get to a hospital



## Tech. Corner

#### Air Brakes and Maintenance

Owners should adhere to an overall maintenance schedule to keep their vehicle in top shape. The air brake system is a very important aspect of this schedule and should be tended to regularly.

A common scenario: your air dryer was just serviced and a new filter and desiccant cartridge were installed and the owner's manual states you don't need this serviced for two more years. You feel like you're covered and don't need to think about those parts for a couple of years, right? Well, we are talking about mechanical devices here and yes, these handy contraptions don't always do what they were intended to do. See Murphy's Law.

The air dryer is intended to collect and remove air system contaminants before they enter the brake system. If your vehicle is equipped with "automatic drain valves", you might feel like you don't have to do anything because they're automatic and should do this collecting and ejecting for you. See Murphy's Law again.

You can manually drain your vehicle's air tanks to ensure everything is working properly by pulling on the lanyard cords. Now, we don't mean you should just walk over to them and pull them open until all of the air is depleted. You should inspect the valve area while lanyards are pulled, holding the drain valves open for 10-15 seconds, paying attention to what is coming out. Moisture is an indication that the dryer is not functioning properly. Signs of oil may indicate a compressor problem. You should not see any puddles or wet marks on the ground when done. If you do, have your vehicle inspected at an authorized Freightliner dealer. (*Please note the very first time you do this test there will be some moisture in the tank due to condensation, which is normal.*)

How often you should manually inspect the air tanks is debatable. At an absolute minimum, the air drain lanyards should be pulled every six months, but FCCC recommends doing it during every pre- or post-trip inspection. There is a slightly greater benefit in performing this test as part of the post-trip inspection, meaning after you first pull in to start your stay. Doing this upon your arrival will allow for time to schedule repairs if needed and plan your departure date, when you know your vehicle's air brake system is functioning properly. However, we urge you to perform this in your pre-trip inspection if your vehicle was parked for long a period of time. Then, inspect again at your next arrival.

Our goal is for maximized on-the-road safety and zero downtime. Maintaining your vehicle correctly is essential to keeping you running smoothly and safely.

## Have You Oiled Your Batteries Lately?

For those of us that still have the wet cell batteries. Sealed and AGM this will not apply to.

This is an interesting subject I have been following in the web for a couple of years. The theory is that when charging your battery, hydrogen and oxygen gases working there way to the surface are slowed by the oil. When the bubble pop, less acid mist is given off. With less mist and fumes, the tops of the batteries stay dry and the causes of corrosion are far less than when all the gas and fumes get vented.

I tried this two years ago and this is what I have experienced to date. I added 4 ounces of mineral oil from my local drug store to each cell on all four of the coach batteries. I live in the desert Southwest and I was using about 2 gallons per year of distilled water to keep up with the evaporation due to charging and the low humidity. Since I added the oil this has dropped by over half, and the tops of the batteries stay clean and dry with the exception of road dust that does still accumulate. I do coat the battery posts, but even doing that in the past I would see some corrosion, but not anymore.

I still monitor the water level and top then off as before, keeping the water level about 1/8<sup>th</sup> inch below the stem sticking down in the cell. The water goes right through the oil with no problems.

As I stated, I used mineral oil from the drugstore. There are some commercial additives (oils) that are available out there for you to purchase. I have seen these at battery distributers in the last 6 months. One of the sites that offers this is <u>http://www.thermoilbatteries.com/</u>

So if anyone asks if you oiled your batteries lately you can say "not yet, but I'm thinking about it".

3 When "Trip Center" is on the screen and highlighted press the T button

4 "Setup" should be on the screen now

5 Hit the T button until "Alarm and Time/Date" show up

6 Use down arrow to highlight the ""Time/Date line".


7 Push and hold the E button until the "AM & PM" flash.

8 Use the up and down arrows to make your selections and then hit E to move to the next field until all are correct and at the end E will exit this mode and save the settings.


