Governing Board Meeting, Indianapolis, Indiana August 27, 2012

The meeting was opened at 9 a.m. by President Charlie Schrenkel. 315 out of 473 chapters, or 67%, of all chapters were represented.

Will Young, Nat'l. Treasurer, indicated that FMCA's fiscal year runs from Oct. 1, 2011-Sept. 30, 2012, that Bank of America & Windsor are FMCA's financial managers. He indicated that both family and commercial memberships are declining and magazine advertising revenue is down. The 10-month 2012 total operating revenue variance is (\$1,097,582). For the same period total operating expenses are under budget (\$951,019).

By-law amendments were passed concerning holding electronic meetings at the Executive Board, Committee, and Chapter levels.

A by-laws amendment passed that a member may hold an office in two chapters; however, he/she may not hold the position of national director or alt. national director in more than one chapter.

The motion to bring towables in as members was defeated. However, the national, areas, and chapters of FMCA can still invite towables as guests to our rallies and conventions.

A motion passed which defines the relationship with the Investment Manager and the ability to invest no more than 5% in Real Estate Investment Trusts (hopefully to get a better return).

A motion passed to remove all stipends, mileage and per diem for all volunteers working at national conventions.

Motions passed regarding chapter national director's and alternate national director's responsibilities to clarify that Temporary Delegates must be members of the chapter they are representing at Gov. Bd. meetings. FMCAssist Program - The current provider, On-Call, will terminate its services as of Sept. 30, 2012. It has become cost-prohibitive for FMCA to continue to pay for this service.

A motion carried that the FMCAssist Program be a member-purchased benefit after Sept. 30, 2012. The member-purchased premium is anticipated to be \$105 per year for a family or 2-member coverage or \$85 per year for individual member-purchased plan.

50th Anniversary Life Membership — Since 2013 is FMCA's 50th anniversary, a 50th Anniversary Life Membership (dues only) will be made available for purchase at the price of \$1050. Life Membership Awarded — Judy Czarsty was awarded a Life Membership, Past National Officer attachment plates, and her picture on the wall at FMCA headquarters with other past presidents.

2013 Budget was approved with a projected operating revenue reduction of 17% from the 2012 budget. Under the Expense category a motion carried to eliminate the early-bird registration fee reimbursement for Governing Board members (open-ended). A motion carried that \$10,000 Area Support for rallies be included in the 2013 budget. A motion carried to have membership dues be an item on every Governing Board meeting agenda with a recommendation of the Executive Board for dues to remain the same, to decrease or increase with notice given to the Gov. Bd. Members to meet notification requirements specified in FMCA's by-laws. Motion carried to accept the 2013 Budget as amended which should result in a \$107,019 surplus in 2013.



RV TRIP TIPS for the POOCH

Dogs enrich our lives in every way and they deserve a road trip too. The only drawback... they can't use our restroom facilities... so they compel us to "stop and smell the roses" every so often. Here are a few tips to keep them safe and happy on the road.

SAFE EXIT

Dogs tend to get excited when the RV stops and can TAKE OFF RUNNING when the door is opened. Watch out for any sneaky escapes and be prepared. Not every place you stop will be safe; oncoming traffic and other dogs nearby can cause them to become just as excited as you get meeting new friends! Keep your dog safe; put a leash on before you open the door.

HEALTHY PASSPORT

Make sure all tags on their collar are current! Carry a copy of a health certificate issued by your veterinarian clearly identifying your dog and certification rabies and all other necessary vaccinations have been updated during the preceding 36-month period. This is a must if you plan to travel from the United States to Canada. While it is rare you will need to show the certificate in the U.S., it never hurts to be prepared.

R-E-S-P-E-C-T - SING IT!

Respect all the rules of campsites and parks. That can mean a special Poop Park or a Dog Run Area and leash rules. You don't want to be asked to move on if your dog misbehaves or is running amuck. Dogs in a strange new place will follow their nose so keep that leash on so he will not get lost. And be prepared, you may need to pay a little extra as some camps and parks have a pet fee.

Always carry poop bags (or try recycling plastic grocery shopping bags but watch for holes). A trick: Use the bag like a glove by putting your hand inside, pick up the poop, then turn the bag inside out while removing your hand and tie the top shut-quick and easy.

PARATROOPER POOCH

D-rings work great! Hook it on his leash and then hook the D-ring to your belt loop. You'll have both hands free. When at camp, tie a long rope to a picnic table, tree or the bumper of the motor home and tie the other end to the hand rail just outside the RV door. Next time your pooch needs to go out, get his leash, clamp on the D-ring and hook it on the rope and out he goes like a little paratrooper.

HOME ALONE

When you go on a tour or shopping and have to leave your pooch in the RV make sure you leave the vents open, have fresh water out, and a few puddle pads on the floor just in case there is an accident. Open windows can become an escape route; right through the screen and a long way down to the ground, so only leave the windows open an inch.

DOGGY DAY CARE ALTERNATIVE

If you're on the road for long periods check for dog groomers in the town you are visiting. Your dog will be pampered, clean and pretty when you pick him up.

HAPPY-CLEAN-HEALTHY HOME SWEET HOME

Give your dog a special place, like a dog carrier or a dog bed. This will provide a secure and comfortable place when he is feeling scared or tired.

Brush your dog outside to remove dander, and loose fur, it's much easier to let the wind take it away than to clog up your vacuum.

If your dog gets nervous or anxious while traveling try Dramine[™]. You may also want to keep a little Benadryl[™] on hand in case of Bee stings or other allergic reactions. Ask your vet for the amounts to be given based on your pooch's body weight.
