The business meeting was held in Gillette and the minutes for the meeting are in this newsletter. I would like to thank all that attended the meeting and there were quite a few.

Many of us moved on from Gillette to Sturgis for the FCOC National rally. We had 78 coaches that attended and as we published before we sold out. I had a total of 103 reservations sent in and I know that there were more that wanted to get in. This is the largest participation we have had for several years. In planning our next two national rallies next year we have reserved 100 spots at Bald Mountain camping resort in Hiawassee, GA for the spring rally following the Perry convention. We also have 100 spaces for Coos Bay, OR rally that will be in August following FMCA Convention in Redmond. The registration form is in this newsletter for Bald Mountain and we already have over 20 signed up for it. So if you want to attend it would be advisable to get your registration in as soon as possible.

The Coos Bay, OR rally will be somewhat different for registration than we have done in the past. It will be a call directly to the resort for your registration and along with that you can use a charge card or debit card for the first time for a national rally.

Those are the national rallies for next year. We also have three area rallies already either fully planned or in the works. There will be a Western rally at 29 Palms in S. California in January. Also in January there is a S. East Area rally at the Florida super show. There is one more that is in the works and that will be a pre FMCA Perry convention. This will be held in Gaffney the week before FMCA convention in Perry. We will have the information for that in the next newsletter and on the website as it comes together.

We are trying to do more of the area rallies since not everyone can jump across the country. We have had some suggestions about holding one in the Northeast and in the South central areas. So if you know of a camping facility that can hold 30 or so coaches and has a meeting hall that can accommodate our needs please let me know.

#### **FMCA** Corner

The 2013 Governing Board was called to order at 9 AM on Wed., June 19, 2013. There were 327 out of a possible 425 chapters in attendance, both morning and afternoon.

The financial report was given by Wil Young. Wil reported that the club is \$457,207.00 under budget as of April, 2013. The Executive Board and the Finance Committee agreed to move FMCA's investments from The Bank of America to The Windsor Group Ltd. At last report we have \$7,988,439.00 in investments. The 2014 budget was presented and approved by the Governing Board. The revenue side is projected at \$7,799,878.00 and the expenses are projected to be \$7,757,851.00 which shows an operating surplus of \$42,027.00.

FMCA has now gone digital with the Family Motor Coaching Magazine. To read it on line go to www.fmca.com , then click on magazine, or www.fmcmagazine.com/digital. You must be signed on to your account to view the magazine. If you don't have an account set up, click on create an account below sign in on the home page and follow the instructions.

FMCA will benefit from having a year-long presence in 60 million households, including a fiveminute educational documentary profile of the association, a one-minute commercial segment produced for network distribution broadcast on primetime in 84 million homes via MSNBC, and CNBC, and airing 400 times in the top 200 Direct Marketing Areas on such networks as CNBC, CNN Head News, The Learning Channel, and the Discovery Channel. In addition, FMCA will be a commercial sponsor for The Texas Tenors on their Public Television national membership campaign tour. This concert will be aired over the PBS national membership drive during the December holidays, as well as during the spring 2014 membership drive. The Texas Tenors will be performing during FMCA's 89th Family Reunion and Motorhome Showcase in Perry, Georgia March 2014.

Katherine and Larry Henley will be the Rally Masters and David and Rachael Cutherbson will be the Assistants. Report is attached.

Mary Costigan gave a membership report. A lot of members are using pay pal to renew their membership. She encouraged members to access the web site to obtain information about the Club. When members received the newsletter by e-mail, it is a financial savings for the Club. Vice President Area Operations West Katherine Henley reported on the FCOC Operations West Rally in Colorado Springs, CO. They had a great time but had to cancel the train ride due to the fires and smoke in the area.

Web Master Dave Violette gave an update on the membership data base. Soon members will be able to purchase and pay for merchandise on line and register and pay for rallies/events on line. He is also expanding some of the reports on line that our officers need to use and has added a seasonal address with start and end dates feature. If members have any suggestions to help improve the web site, to please let him know. He also said the information on FCOC's web

This means those members do not get reminded about upcoming membership expiration, rally notices, changes in rally schedules or plans, news about the organization, and many other topics of interest to FCOC members. For many such systems you can allow mail from any sender at a domain, but if your service requires an actual email address instead of just the domain name, you should use Reply@FCOCRV.ORG or Reply@FCOCNEWS.COM as the address. While these addresses will allow you to receive the automated emails, they still will not allow you to receive direct communications from an officer of the club. For that you need to add President@FCOCRV.ORG, VP.Membership@FCOCRV.ORG, Webmaster@FCOCRV.ORG, or similar. But since many officers use their own personal email for communications you still may not receive important communications.

The Freightliner Chassis Owners' Club Southeast Area will kick off the 2014 rally season with the Florida RV Super Show at the Tampa fairgrounds. The rally entry date is January 14. The show dates are Jan. 15 thru 19. The cost is \$185 which includes 5 nights of **DRY** camping (**NO WATER OR DUMP STATION ON GROUNDS**), 30 amp Electric, show entry, entertainment, and coffee and donuts, Thru.-Sun. Additional information is on the FRVTA application attached. We will have a **MEET** and **GREET** each afternoon at 4:30 PM (FCOC will supply the liquid refreshments under the FCOC tent). Tuesday evening please bring a dish to pass and your own place settings and chairs. Other evenings will be light snacks. If your last name starts with A-F (Wed), G-M (Thru), N-S (Fri) and T-Z (Sat.) please bring a snack. **You will need to register early as the rally sold out early in Dec. last year.** 

To come in and park with the FCOC group you must do the following:

- (1) Under CLUB/GROUP on the FRVTA application form fill in FREIGHTLINER CHASSIS OWNERS CLUB or FCOC. (The attached application is filled in for you.)
- (2) WHEN YOU GET YOUR CONFIRMATION from FRVTA, E-MAIL OR CALL ME TO GET ON MY FCOC LIST as FRVTA is not informing the rally leaders of who is coming in with the group this year. E-mail rhopper517@aol.com, Phone 772- 559-3522. (I will not be available by phone the whole mouth of August but I can get e-mail.)
- (3) Tape an 8-1/2 x 11 sheet of paper in the lower left hand corner of your windshield with FCOC in big letters so the flag men can read it (laying on the dash won't do.)
